

Budget recommendation is to decrease 2012 tax levy by \$1 million By Randy Maluchnik, Carver County Board Chair

ollowing the County Board's goal to decrease the tax-impact on average-value homes, the County Administrator recommends setting the preliminary 2012 tax levy at \$45 million, a decrease of \$1 million from 2011.

Property taxes provide most of the funding for local government services in Carver County. Property taxes paid by Carver County residents are distributed to the County, local school districts, governing municipalities, and special taxing districts. Each property's share of taxes is determined according to its assessed value, the applicable property tax levies of each taxing district, and property classification (i.e. commercial, single family residential, farmland, etc.).





As part of determining its budget strategy, County Administration estimated it will cost an additional \$1.3 million to maintain the same general level of services in 2012. County divisions and offices were asked to cut their budgets by 2.9% to offset this increase in operating costs. This process identified \$1.3 million in levy savings countywide.

Initially it was thought budget cuts and flat-ling the levy would enable the County to meet its tax impact reduction goal. However, a decision by state lawmakers at the close of the recent state government shut-down to eliminate the Market Value Homestead Credit (MVHC) prompted a new recommendation: Lower the proposed property tax levy by \$1 million to \$45,179,720. This change offsets the loss of revenue from the MVHC that previously subsidized the tax levy for County taxpayers.

To compensate for the elimination of MVHC, lawmakers changed property class tax rates by adding a market-value exclusion for lower-value homes. This change will shift more of the tax burden to commercial properties and higher-value homes. In lowering its levy, the County eases the increased burden on those properties while pursuing the goal of decreasing taxes on average-value homes.

The loss in revenue from the elimination of the MVHC will be made up by using \$1 million in County Program Aid from the State. These funds had been slated for funding capital projects on a pay-as-you-go basis. They will instead be used to fund general operations in 2012.

Under the direction of the County Board, Carver County has decreased the County's tax impact on the average-value home every year since 2005. Owners of average-value homes should again see the County's portion of their tax bill decrease slightly for 2012. However, properties that increase in value, or even decrease in value at a slower rate than most properties, may experience increased property taxes. If your County property taxes are going up for 2012, your increase is being driven by the tax burden shift despite Carver County reducing the 2012 property tax levy \$1M from the 2011 property tax levy.

The Carver County Board sets the 2012 preliminary tax levy in September while maintaining the ability to lower, but not increase, the final tax levy. The County Board will vote to adopt the final 2012 levy, budget and 2013 Long-Term Financial Plan after a public hearing in December.

Board Plans Exciting Upgrades in 2012

he Jonathan Association Board of Directors has laid out some very exciting plans for improving a number of common areas in our

community for next year. During deliberations in its monthly meetings in September and October, the Board decided to make the following upgrades:

Tot Lot Playgrounds

Jonathan's "2039 Plan" (Reserve Study) calls for the repairing/ replacing of various playground equipment and structures in Neighborhoods 4, and possibly 5 and 11 as well. Resources will be spent effectively as needed.



Henry Creek Park

Previously known as either "Out Lot B" or "Henry Creek Park", this location near the intersection of Clover Ridge Drive and Schoolmaster Drive has been designed as a passive use gathering area that will emphasize native grasses, wildflowers, and a modest trail among carefully selected deciduous trees. In 2012, a beautiful new sign will be added along with a bridge in the low lying area.

Juliet Park

Previously known as "Out Lot A", this location near the intersection of Romeo Court and Clover Ridge Drive now features a scenic overlook gathering spot among carefully selected deciduous trees; native grasses and wildflowers; and will also include a walking trail and a small foot-bridge. In 2012, a beautiful new sign, bench, trash receptacle, and doggi pot will be added.

Clover Ridge Drive

There will be an additional 50+ new boulevard trees planted along this scenic and important street which runs north/south from Schneider Court in Neighborhood #12 all the way down to Engler Boulevard in the Traditions at Clover Ridge neighborhood.

Apple Barn



The Apple Barn, Jonathan's new equipment storage facility, located on the southwest corner of the Karen House property, will be carefully landscaped so as to include a beautiful new rain garden and the addition of numerous shrubs (which will serve as a visual enhancement for the surrounding homeowners in the Bavaria Court and Von Hertzen Circle neighborhoods). Carver County grant money may also be available thanks to the inclusion of rain gardens.

Trail Head Park

This historic location in Neighborhood One represents the original "starting point" of the

Jonathan Trail System. Plans include shrubs and flowers, native grasses, shade-loving perennials, and renovations to the benches so as to restore an original Jonathan gathering area. A huge decorative boulder and a beautiful new sign will also be included.



<u>Trail Repairs & Improvements</u>

Jonathan's "2039 Plan" (Reserve Study) calls for repaving and repairs, in a phased approach, along the trail system throughout Neighborhoods 1-7 in 2012—2013. Resources will be spent effectively in numerous locations in these neighborhoods.

Jonathan Board Approves Budget for 2012

At the November 2011 monthly meeting, the Board of Directors approved the Jonathan Association's operating budget for the 2012 fiscal year. During the months of August, September and October, the Board members had participated in budget

planning "closed session workshops" in which all funding priorities and individual line item expenditures were discussed and evaluated. In order to effectively carry out its fiduciary duty to manage the largest homeowners association in Minnesota, the Board also voted in favor of a 5% increase in the annual assessment for all Jonathan Association homeowners as part of the 2012 operating budget.




In passing the 2012 operating budget, the Board has reaffirmed its commitment to an equitable distribution of financial resources throughout all Jonathan neighborhoods and will continue to adequately fund the areas of special event activities, communications, maintaining and upgrading the publicly-shared common amenities (trails, tot lots, trees, etc.), and the preservation of our distinctive history and heritage. A copy of the 2012 operating budget and a copy of the 2011 balance sheet will be postal-delivered

to each and every Jonathan homeowner in the Annual Meeting Notification packet, which will be mailed in late January.

Blast from the Past—A look back at | For some, the Renaissance Festival has become an annual tradition and for others, once a decade is plenty! Whatever your preference for all that

merriment, few may

remember that the Renaissance Festival actually started in Jonathan. The original location for the festival was in the woods in McKnight Park just north of Jonathan Elementary School. The first Renaissance Festival

was in 1971 and was modest compared to the current

day event.



Admission was \$1.50 and still carried a 60's vibe with lots of beads, people making candles and independent crafters. Included was Shakespearean readings and good food. More than 25,000 people visited the two weekend grand opening of

the festival than named, "A Celebration of Nature, Art, and Life!"

Many of the food and craft booths were originally run by local groups or citizens. Dick Tirk, who was the President of the Jonathan Association, was approached by the Festival to run a booth. For years, the Jonathan Association, in conjunction with the Chaska Civic Theater, operated the "Dueling Buckets" booth, which is still in operation today. Dick Tirk was a faithful participant at the Renaissance Festival for approximately 15 years.



His character, "Sir Rotten", was well known at the Festival with his good natured teasing of maiden and knight alike. The Renaissance Festival stayed in Jonathan only two years as it outgrew its location. It briefly moved to Chanhassen before ending up in Shakopee where it has been for many



The festival has grown from one stage and a clearing in the woods to over 500 entertainers with sixteen stage locations. Compared to the original handful of peddlers, there are now 275 Artisan



booths with crafts from throughout the United States. Foodies alike attend to sample varieties of food fit for a king! Some popular items are the infamous turkey legs, elephant ears, Scottish eggs, or a Smoralicious! Annual attendance has climbed to 280,000 -which makes it the largest in the country.



Delinquent Dues Collection Policy Approved by the Board



↑ the November 2011 monthly meeting, the Jonathan Board of Directors voted unanimously, upon recommendation by the Gassen Management Company, to turn over all of the Association's delinquent homeowner accounts to the Association Dues Assurance Corporation (ADAC). This organization is a nationally licensed and bonded company spanning from Virginia to Hawaii, and ADAC is the nation's leading delinquent assessment collection agency. ADAC is headquartered in St. Clair Shores, Michigan.

ADAC is not paid their collection fees until the delinquent homeowner pays; solely charging the delinquent homeowner, and thus is free to Associations and Property Managers. ADAC replaces attorney hours, paperwork, and overhead with free proprietary internet collection software on a 24/7/365 basis.

"All of the Board members favor a much more aggressive approach to collecting delinquent homeowner assessments," said Jonathan Association President Nate Bostrom. "ADAC has promised us that the one who owes (i.e. the homeowner) is the one who pays," he added, explaining that collection fees and costs will be tacked on to the amount each delinquent homeowner owes to the Association. Jonathan will not be charged fees to cover the collection costs incurred by ADAC.

Board member Brandon Maves heartily endorsed the hiring of ADAC, saying "this sounds like the most cost-effective way to collect delinquent assessment dues." Board Vice-President David Snodgrass agreed, adding that PAYMENT RECORD

"delinquent assessment dues need to be collected and come off our books as soon as possible; we have lots of property improvement projects to complete in the coming years."

As mandated by Jonathan's governing documents (Article XII, Bylaws), each homeowner is obligated to pay the Association's assessments and no owner may waive or otherwise escape liability

for the assessment. The Bylaws also give the Board of Directors (Article VIII, Section 2: Subsection E) the power to disclose, upon demand by any person, any assessment which is in delinquency status. "My opinion is that the Board has the right to publish the information in a

manner in which it deems appropriate," stated Jonathan attorney David G. Hellmuth.

Prior to publishing any information regarding delinquent accounts, the Board is considering providing written notice to all homeowners of its intention to make this information available to the public. "We'll most likely include a memo in the Annual Meeting notification packet which we'll mail out in late January," added Bostrom. "Our goal will be to give

homeowners every chance to pay off their balances before we make this information public."

Board Donates Scale Model to Carver County Museum

At its October monthly meeting, the Jonathan Board of Directors voted to donate the scale model of the early Jonathan New Town Development to the Carver County Historical Society for permanent safekeeping. Currently being stored in the attic of the Karen House, this piece of memorabilia has been languishing in illsuited surroundings for a number of years. After much discussion, the Board voted 6-1 (Linda Frey voted no) in favor of finding a new home for this item, which was a sales tool for the original Jonathan Development Corporation.

"The Jonathan Association does not possess an archival storage facility – nor should it," stated President Nate Bostrom. "As a homeowner's association we're in the business of property management, we're not museum curators." Earlier this year the Board resolved to make every effort to collect, identify, and seek safekeeping for historically significant Jonathan

documents and objects. "We just don't have sufficient means for effectively preserving history, nor can we guarantee protection from fire



and theft," said Bostrom, "On the other hand, Jonathan is blessed to have both the Chaska History Center and the Carver County Historical Society as neighbors who can provide these services."

residents (a third of Chaska's population); 19 tot lot playgrounds; 34 neighborhood entrances; 47 mail stations and bus shelters; 20 miles of paved walking trails; and covers approximately 2,200 acres. In addition, Jonathan also maintains two historic Chaska farmhouses (Karen House and Eitel House) as well as the Lake Grace Pavilion and recreational beach area.

Jonathan is managed by Gassen Companies, which provides professional property management services to homeowner associations in 15 Minnesota counties. The Gassen organization was formed in 1969 and is accredited with the Better Business Bureau.

Jonathan Apple Seeds



George Bender was the first local farmer to sell his property to the "New Town" of Jonathan. His grandfather, Christian

Bender, homesteaded this land in 1854 and he was formally given title to it in a deed personally signed on August 1, 1861 by President Abraham Lincoln. The "Jonathan in Chaska" silo, located on the original Bender farm at Hwy 41 and Hundertmark Rd. was dedicated in October 2001.

In May 1972, Secretary of Housing and Urban Development (HUD) George Romney visited Jonathan to inspect the progress of HUD's "New Communities" Program in Minnesota's first New Town. A Jonathan apple tree was planted to commemorate the visit. George Romney was the former governor of Michigan, and his son Mitt Romney was elected governor of Massachusetts some thirty years later.



Kathleen "Kacie" Brown, born in December 1969 was the very first "native born" Jonathan citizen. Kacie's parents, Bill and Maggie Brown, had moved into Jonathan in October 1968. The Browns were Jonathan's first residential home buyers.
